Time for Saturday burials set at 9am-Noon with completion of last burial at noon Some of the fees were changed. See attached revised fee schedule.

Markers for a 4x5 cremains plot must be flush, not vertical. Allowed are two 16"x28" flush markers.

Dee to try to schedule BOH examination at Ireland Street Cemetery.

New Business

The three solicitations for Mount trees rejected by Select Board. Brenda will get more bids as the legal requirements have already been met by the Cem Comm. Rick said that his opinion as a contractor is that once the date for bidding is past it is unfair to the people who submitted bids to extend the due date and ask for more bids.

Dee has been sorting out Cemetery accounts with Town accounting firm. Problems included 4 different names for a single account on different reports.

We have an appointment with The Select Board, Larry Holmberg and Mrs. Osborne at Mount Cemetery to go over the terms of the donation of land they will make to the Cem. Comm.

Chesterfield Cemetery Commission

The proposed charges are as follows:

Right of burial Fees

Town Resident:

\$250 Right of burial license \$250 Cemetery Stewardship charge per lot (non-refundable)* \$150 Cremains plot plus \$150 Stewardship fee (non-refundable)*

Non-Resident:

\$650 Right of burial license

\$250 Cemetery Stewardship charge per lot (non-refundable)* \$350 Cremains plot plus \$150 Stewardship fee (non-refundable)*

* Cemetery Stewardship fees provide for general upkeep and maintenance of the cemeteries.

Grave Opening/Closing Fees

Only the Cemetery Commission will arrange to open/close graves.

- a. Full body burial: \$1,000 Saturdays 9-12: additional \$250
- b. Cremains only: \$200 Saturdays 9-12: additional \$50

One hour is allowed for a graveside service. Beyond one hour, additional \$50/hour fee applies.

Plot Markers

Purchaser of right to burial is responsible for cost of individual plot markers. Check with Cemetery superintendent for current cost.
